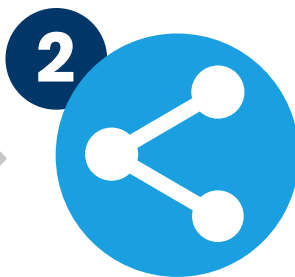

## 1. Living and working in Australia

If you are not an Australian citizen or New Zealand Citizen, you will need to obtain a valid Visa to live and work in Australia. We have listed the most common Visa's below, however as we are not a migration agency it is essential you use Australian Government website for the most up to date information on eligibility, restrictions, and requirements.

### (1.1) Working Holiday Visa

Cost = \$510.00 + Police Checks + Health Checks

Length = 12 Months in the first instance

To obtain a Working Holiday Visa, you must not have dependent children that you intend to bring to Australia. This Visa is offered in three stages and requires 'specified work' to be complete, to obtain the 2nd and 3rd year visa options.

- First year visa is 12 months in length, to apply for 2nd year Visa you must complete 3 months of specified work
- Second year visa is 12 months in length, to apply for 3rd year Visa, you must complete 6 months of specified work
- Third year visa is 12 months in length. There is no option to stay in Australia after this point, on this visa type. You must look at other routes to stay in the country.

Up until June 30th, 2023, the [Work Restriction 8547](#) has been relaxed, meaning you can be employed by the same employer for +6 months. From the 1st of July 2023, this restriction is reinstated.

## (1.2) Partner Visa

Cost = \$8,085.00

Length = Indefinite, this is a route to Permanent Residency

If you have a partner who is an Australia Citizen, New Zealand Citizen or Permanent Resident of Australia, you may be eligible to apply for a de-facto visa. Information on this visa can be found here:

## (1.3) Sponsored Visa

Cost = \$4,000.00

Length = Dependant on Visa - Generally 2+ years

There are several Sponsored Visa options that you can apply for to live and work in Australia on a longer to more permanent basis. These can be direct with the State or Territory you wish to work in, rather than direct with an Employer (School), which gives you more freedom/autonomy to choose your employer.

## 2. Teaching in Australia



Total Schools = ~9,500



Total Teachers (FTE) = ~303,539

Formal schooling lasts for 13 years in Australia and is compulsory until 16 years of age (Year 10). Schools in Australia generally have up to 30 students per class.

## 2. Teaching in Australia

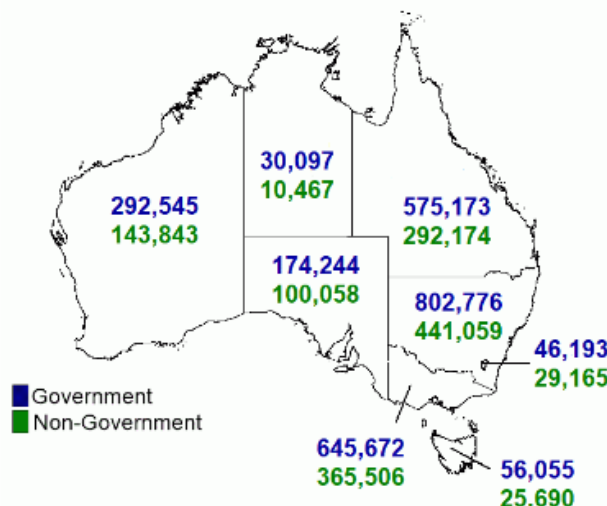
### ✓ Essentials to teach in Australia:

- You must have 4 years of tertiary level educational experience (Example: 3-year degree and 1-year Masters, or 4 year education degree)
- International police check for anywhere you have lived for +12 months in the past 10 years
- Australian National Police Check
- Certified original copy of your university transcripts
- 100 points of identification
- Valid Working Visa
- Valid Teacher Registration in chosen state or territory

Prospero Teaching Australia supports schools based in New South Wales, Queensland, Victoria and the Northern Territory. We recruit for Early Childhood Centres, Primary Schools, and Secondary Schools.

This is a quick guide and by no means a comprehensive overview of our services. We will be able to discuss this in depth as we get to know you, however this will act as a good point of reference.

## 2. Teaching in Australia

### Early Childhood Centres

~13,589 approved early childhood centres across Australia, including Centre Based Day Care and Outside School Hours Care.

Early Childhood Centres cater to children from 0-5 years of age across Australia. There are 5 broad categories, including home-based care, centre-based care, family day care, business related creches and outside school hours care.

## (2.1) New South Wales

★ Capital City: Sydney

👥 Population: 8.1 Million

💰 Starting Teacher Salary: ~\$73,000 AUD

The teaching board in New South Wales is NESA and teachers have a starting salary of around \$73,000. New South Wales is on the East coast of Australia, with the capital city being Sydney. Prospero Teaching predominantly supports Independent and Catholic Education schools based in and around Sydney, as well as regional hubs across the state.

### NESA Teacher Registration

We will provide a short overview on NESA, however it is always recommended you look at the [website](#) directly to ensure the information is up-to-date

💰 Cost: ~\$100.00 annually, ~\$80.00 for Working With Children Check (in country) + other costs such as Overseas Police Checks.

i How to apply: You can only complete your application in country and is recommended to arrive 4 weeks prior to starting your new position. \*Prior to arriving, you can create a NESA account and upload the requested certified documentation, however you must be in NSW to apply for your Working with Children Check at a Service NSW.








## (2.2) Victoria

 Capital City: Melbourne


 Population: 6.6 Million


 Starting Teacher Salary: ~\$74,000 AUD

The teaching board in Victoria is the VIT, and teachers have a starting salary of around \$74,000. Victoria is on the Southeast coast of Australia, with the capital city being Melbourne. Prospero Teaching predominantly supports Independent and Catholic Education schools based in and around Melbourne, as well as regional hubs across the state.

### VIT Teacher Registration

We will provide a short overview of VIT, however it is always recommended you look at the [website](#) directly to ensure all the information is up to date

 Cost: ~\$167 annually, ~\$62 National Police Check, +other costs such as overseas police check.

 How to apply: You can apply for your VIT whilst based overseas. It is recommended you apply for your VIT within 3 months of moving to Victoria, and no later than 6 weeks prior to arrival (ideally).

Apply and complete your VIT registration application at least 4-6 weeks before arrival.





## (2.3) Queensland

★ Capital City: Brisbane

👥 Population: 5.1 Million

💰 Starting Teacher Salary: ~\$75,000 AUD

The teaching board in Queensland is the QCT, and teachers have a starting salary of around \$75,000. Queensland is on the Northeast coast of Australia, with the capital city being Brisbane. Prospero Teaching predominantly supports Independent and Catholic Education schools based in and around Brisbane, as well as regional hubs (coastal and regional) across the state.

### QCT Teacher Registration

We will provide a short overview of QCT, however it is always recommended you look at the [website](#) directly for the most up to date information.

💰 Cost: ~\$289 to apply and a further \$95 / year to maintain + costs of Overseas Police Check

📄 How to apply: Apply and complete your QCT registration application at least 4-6 weeks before arrival.





## (2.4) Northern Territory

★ Capital City: Darwin

👥 Population: 246,500

💰 Starting Teacher Salary: ~\$77,000 AUD

The teaching board in the Northern Territory is the NT TRB, and teachers have a starting salary of around \$77,000. The Northern Territory is based in Central North Australia, and the capital city is Darwin. Prospero Teaching supports Government, Independent and Catholic Education schools based in Darwin, as well as Remote (Category 1-3) locations across the Territory.

### NT TRB Teacher Registration

We will provide a short overview of NT TRB, however it is always recommended that you look at the [website](#) directly for the most up to date information.

💰 Cost: ~\$142 to apply for registration, plus additional costs for the OCHRE (Working with children check) and overseas police checks.

📄 How to apply: Apply and complete your NT TRB registration at least 4-6 weeks before arrival.





## 4. Life Administration

### (4.1) Bank Accounts

You generally cannot open a bank account before you arrive in Australia. It is recommended to look at WISE (International platform) for arrival and joining a bank upon arriving in the country.

## **(4.2) Transferring money internationally**

Based on international arrivals into Australia – WISE is the most recommended platform to transfer currency into Australia Dollar. WISE also allows you to use a Debit card and transfer between international “wallets” in real time.

## (4.3) Australian Taxation and residency status

Australian Taxation is all based on your Residency Status when living and working in Australia. All Working Holiday Maker (subclass 417 and 462) as Foreign Residents for tax purposes. To understand your Residency Status, you must look at the Australian Taxation Office website.

To understand your take home pay, you can use the [PayCalculator](#) online and ensure you highlight your Tax Category to ensure the take home figure is accurate.

\$45,001 - \$120,000	\$6,750 plus 32.5 cents for each \$1 over \$45,000

\$180,001 and over+	\$53,325 plus 45 cents for each \$1 over \$180,000

## **(4.4) Health Insurance**

You must hold adequate health insurance to live and work in Australia, this is generally outlined on your Visa requirements.

### Reciprocal Health Care





Under the reciprocal healthcare arrangements between Australia and 11 other countries, citizens who are travelling to Australia on a reciprocal passport are entitled to limited subsidised health services from Medicare (public health equivalent to the NHS). Please note, to be eligible for Medicare in Australia, you must be residing in that prior to moving to Australia.

### Overseas Visitor Health Cover

You are recommended to take up Overseas Visitor Health Cover (OVHC), which is offered by private health insurance companies in Australia. Some major companies offering OVHC include BUPA, NIB, Medibank, Allianz Care, and iSelect.
